

- 3. If Miss Bush has to reschedule or cancel your appointment for any reason relating to the Covid-19 pandemic, fees are fully refundable.
- 4. Payment is by bank transfer using the bride's name and appointment date as reference.

- 8. No change or refunds will be given and receipt/credit notes cannot be redeemed for cash.
